1. Privacy and Cookie Policy

of visitors to the <http://www.ekinenerji.com> website (" **Data Owners** "), operated by **Mevosa Energy Inc.** (" **Company** ") as the Data Controller, is one of our Company's leading principles. The Website Privacy Policy (" **Policy** ") explains (1) the processing of Data Owners' personal data, (2) Cookie Policy, and (3) the effectiveness of the Website Privacy Policy .

1.1 Processing of Personal Data of Data Owners

Personal data obtained when you visit our website may be processed by the Company, as the data controller, within the scope described below, in accordance with the Personal Data Protection Law No. 6698 (" **Law** "). 1.2 Purpose of Processing Your Personal Data

Your personal data obtained through your visit to our Website may be processed by the Company in accordance with Articles 5 and 6 of the Law for the purposes listed below:

- Carrying out the necessary work by our relevant business units and carrying out the related business processes in order to carry out the commercial activities carried out by the Company,
- To ensure that relevant people benefit from the products and services offered by the company, our business units carry out the necessary work and carry out the relevant business processes,
- Planning and executing the activities required to recommend and promote the products and services offered by the company to the relevant people by customizing them according to their tastes, usage habits and needs.
- Creating membership registration and account and keeping related records,
- To detect system errors, monitor performance, improve the operation of the website, provide maintenance and support services and backup services so that the Data Owner can benefit from the services provided,

1.3 Parties to Which Your Personal Data Is Transferred Transfer Purpose

Your personal data obtained through your visit to our website may be transferred to our business partners, suppliers, legally authorized public institutions in line with the purposes of processing your personal data; to perform finance and accounting transactions, to establish contractual relationships, to improve the Data Owner experience (including improvement and personalization), to ensure the security of the Data Owner , to detect fraudulent or unauthorized use, to correct errors related to company services, and to outsource service providers, hosting service providers (hosting services) in accordance with the personal data processing conditions and purposes specified in Articles 8 and 9 of the Personal Data Protection Law.

1.4 Method and Legal Reason for Collecting Your Personal Data

Any information that identifies or makes your identity identifiable is " **personal data** . " During your visit to our website, your personal data is collected through cookies, which are technical communication files, in accordance with the data processing conditions stipulated in Articles 5 and 6 of Law No. 6698 .

Rights of Data Owners

We hereby inform you that, as a personal data owner, you have the following rights pursuant to Article 11 of the Law:

- 📄 Learning whether your personal data is being processed,
- 📄 Request information regarding your personal data if it has been processed,
- 📄 To learn the purpose of processing your personal data and whether they are used in accordance with their purpose,
- 📄 To know the third parties to whom your personal data is transferred, either domestically or abroad,
- 📄 To request correction of your personal data if it is processed incompletely or incorrectly and to request that the action taken in this context be notified to third parties to whom your personal data has been transferred,
- 📄 To request the deletion or destruction of personal data in case the reasons requiring processing are eliminated, even though it has been processed in accordance with the Law and other relevant legal provisions, and to request that the action taken within this scope be notified to third parties to whom your personal data has been transferred,
- 📄 To object if a result against you arises as a result of the analysis of processed data exclusively through automated systems,
- 📄 To request compensation in case you suffer damages due to the unlawful processing of your personal data.

1.7 How We Use Cookies We use ?

Cookies are small text files stored on your device or on a network server by the websites you visit through your browser.

The main purposes of using cookies on our Website are listed below:

- To improve the Website and offer new features on the Website and to personalize the features offered according to your preferences;
- To ensure the legal and commercial security of the Website, you and our Company.

1.8 What types of cookies do we use ?

Like most online services, our website uses first-party and third-party cookies for a number of purposes. First-party cookies are mostly necessary for the website to function properly, and they do not collect any of your personally identifiable data.

Essential: Some cookies are essential for you to experience the full functionality of our site. They allow us to maintain user sessions and prevent security threats. They do not collect or store personal information. For example, these cookies allow you to log in to your account, add items to your cart, and checkout securely.

Statistics: These cookies store information such as the number of visitors to the website, the number of unique visitors, which pages of the website have been visited, the source of the visit, etc. This data helps us understand and analyze how well the website is performing.

Marketing: Our website advertises products we sell. These cookies are used to personalize the ads we show you so they're meaningful to you. These cookies also help us track the effectiveness of these advertising campaigns.

Session Cookies

(*Session Cookies*)

Session cookies are temporary cookies used by our visitors during their visit to the Website and are deleted after the browser is closed.

For example, you can fill out online forms consisting of multiple pages.

Persistent Cookies

(*Persistent Cookies*)

Persistent cookies are types of cookies used to increase the functionality of the Website and to provide a faster and better service to our visitors.

These types of cookies are used to remember your preferences and are stored on your device through browsers.

Some types of persistent cookies can be used to offer you personalized recommendations, taking into account factors such as your purpose in using the Website.

Thanks to persistent cookies, if you re-visit our Website using the same device, it will be checked to see if there is a cookie created by our Website on your device. If so, it will be understood that you have visited the site before and the content to be delivered to you will be determined accordingly, thus providing you with a better service.
