As the data controller of your personal data **The Company** or the data processors it authorizes by taking the necessary security measures may collect, directly or indirectly, TR Identity Number, name, surname, address, tax office, tax number , telephone and e-mail information, contact information and other personal data that are the basis for invoicing and taxation, in order for the Company to provide its products and services to its customers under the best conditions, to provide products or services reliably and uninterruptedly, to maximize customer satisfaction, to perform accounting and invoicing **transactions** , to make payments , to perform various transactions related to the aforementioned services , to carry out and develop operations, to promote the aforementioned products and services or different products and services, to carry out marketing, advertising and campaign activities, to inform customers about opportunities, campaigns and other services and to fulfill the requirements of the contracts concluded with customers ; I hereby declare that my personal data may be processed in accordance with the general principles expressed in Article 4 of the Law on the Protection of Personal Data No. 6698 ("PDPL"), especially the principle of preservation for the period stipulated in the legislation or necessary for the purpose of processing (5th year in accordance with the VUK Law, 10th year in accordance with the Turkish Code of Obligations); that they may be obtained, recorded, stored securely in physical or electronic environment for a period appropriate for the purpose of processing , preserved, changed, rearranged, disclosed and transferred in accordance with the legislation , taken over , classified , processed or the use of the data may be prevented; that I have been informed by the Company regarding the above- mentioned issues and that I have received clear instructions within the framework of the PDPL Law. I accept and declare that I have consented .

My personal data may be disclosed by the Company , in accordance with the purposes stated above , to the Company's branches, employees , officers, group companies, suppliers (the Company and/or its business partners , shareholders , branches, other group companies owned by the company's partners), legally authorized public institutions and organizations , to independent audit companies within the framework of legal obligations and legal limitations in order to carry out their activities , and to the business partners and service providers from whom the Company receives services or works together for the execution of the services and/or activities to be provided to me . can be transferred and is open on this matter I accept and declare that I have consented .

However, in accordance with Article 11 of the Personal Data Protection Law and the relevant legislation , I have the right to contact the Company to learn whether my personal data has been processed, to request information about my personal data if it has been processed, to learn the purpose of processing my personal data and the reasons for their processing. used for its intended purpose I have the right to learn whether my personal data is used , to know the third parties to whom my personal data is transferred at home or abroad , to request correction in case my personal data is processed incompletely or incorrectly , to request deletion or destruction of my personal data if the reasons requiring the processing of these data are eliminated , to request that these correction and deletion requests be notified to third parties to whom my personal data is transferred , to object to a result arising against me by analysis of the processed data exclusively through automated systems , to request compensation in case I suffer damage due to the unlawful processing of my

personal data , and to exercise these rights , I can make my request, including the necessary information to identify me and explanations regarding the right I request to exercise, by filling out the form from the link www.ekinenerji.com/verisahibibasvuruformu and deliver a signed copy of the form to the company headquarters: İVEDİKKÖY MAH.
